## **1 General information**

This Report on payments to governments (“the Report”) has been prepared under the requirements of the Disclosure and Transparency Rules Instrument 2014 Report on payments to governments, issued by the Financial Conduct Authority (“the FCA’s Instrument”), to foster transparency of financial reporting in the extractive industries.

The Company (“Magnitogorsk Iron and Steel Works PJSC”) is obliged to prepare the Report under the requirements of the Financial Conduct Authority, since the Company conducts extractive activities and its securities are traded on the London Stock Exchange.

## **2 Basis for preparation**

The Report provides citizens, authorities and independent users with information on payments of the Company – Public Joint Stock Company Magnitogorsk Iron and Steel Works (PJSC MMK) made to governments where the Company performs its extractive activities.

For the purpose of preparing the Report the scope of companies was the same as in the MMK Group’s consolidated financial statements.

Since the MMK Group Companies performed extractive activity in Russia only, the Report discloses payments to governments made by Russian companies only.

The amounts relating to mining operations only are disclosed as the payments. For the purposes of this Report mining exploration means the process of exploration, development of mineral deposits and mining operations.

Due to the inability to determine the portion of tax on profits obligations related to extraction activities in the total amount of the tax, the payment of tax on profits is disclosed for the whole of MMK.

In this Report payments are disclosed by :

- Budgets (federal, regional or local); where the payment has been transferred with the name of the recipient.

•Companies. Payments are not allocated between the Company's projects, as the Group does not make payments to a specific project in favour of governments.

For the purposes of this Report, payments to governments include the following:

- Payments for the right to carry out mining activities in the designated area (license fees, rental fees paid for access to area where extractive activity will be conducted and other payments for the use of sub-surface resources);
- Taxes levied on the income, production volume or profit of the company (income tax, mineral extraction tax).

For the purposes of this Report payments to governments do not include the following:

- Turnover taxes (VAT, sales tax, GST and similar taxes);
- Withholding taxes by an entity acting as tax agent (personal income tax, social taxes and other similar taxes) ;
- Property, land and infrastructure taxes;
- customs and stamp duties , export duties and other payments related to export and transportation of mineral resources.

payments of royalties, dividends or bonuses to governments .

### **3 Reporting currency and materiality level**

Payments in favor of the state bodies of the Russian Federation are performed by the MMK Group Companies in the currency of the Russian Federation (the Russian ruble), in connection with which the report has been prepared in millions of Russian rubles..

To determine the materiality threshold of EUR 100,000 established by the legislation, the amounts of payments in the reporting currency have been converted into euros at the average exchange rate for the reporting year.
